- Incorporate the rich local resources in the educational process.

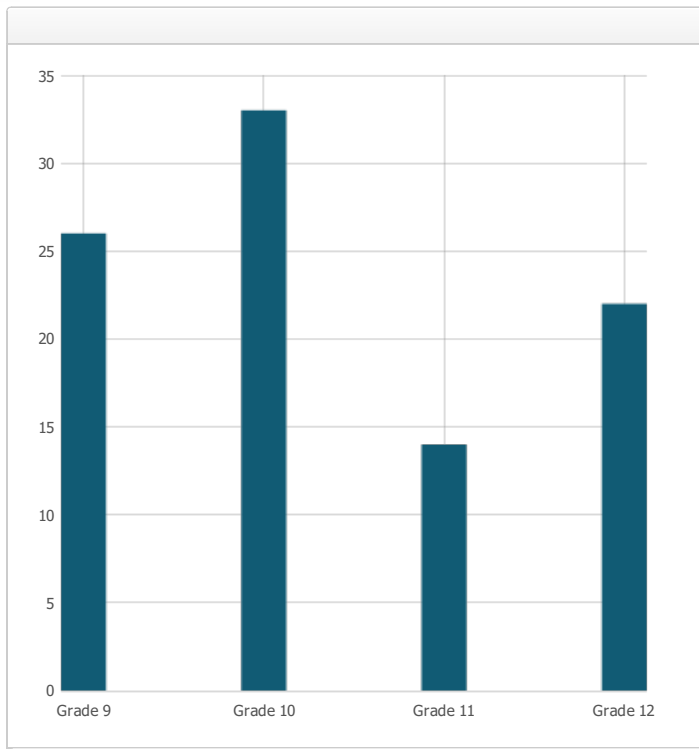

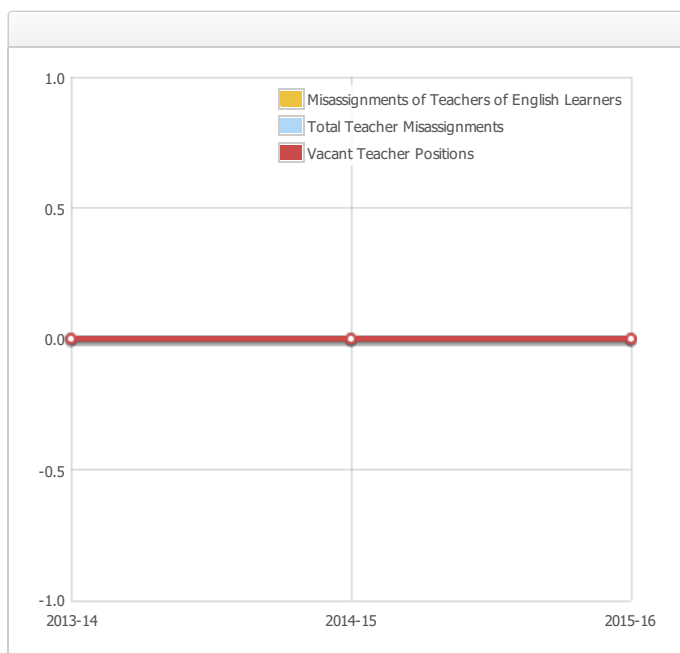
