- Respond, flexibly, to the needs of a diverse community. Incorporate the rich local resources in the educational process.

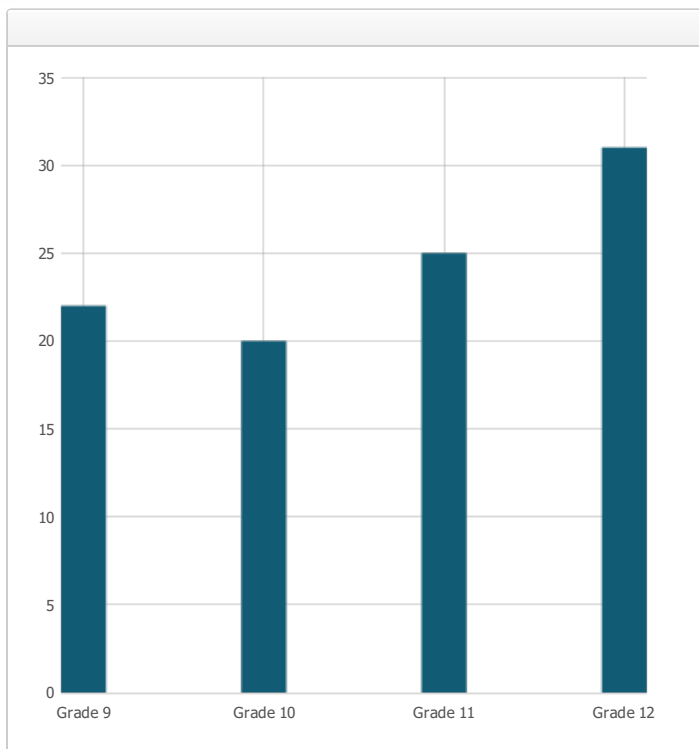

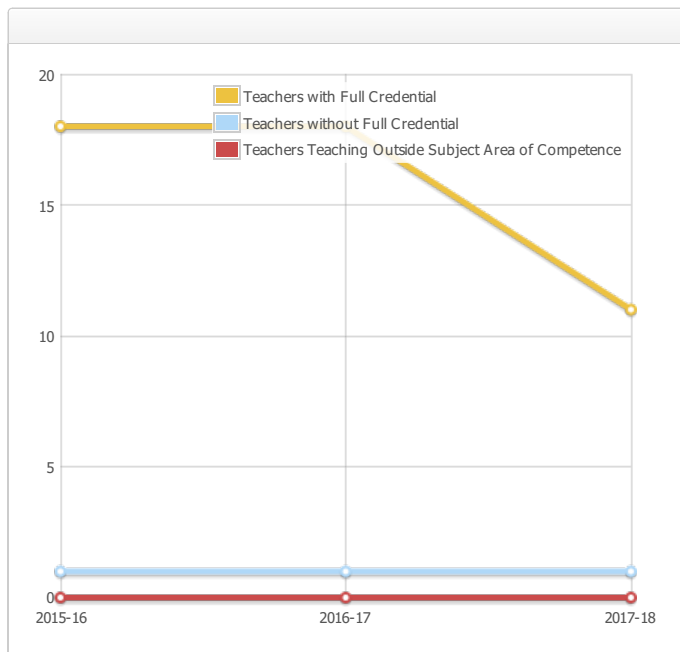

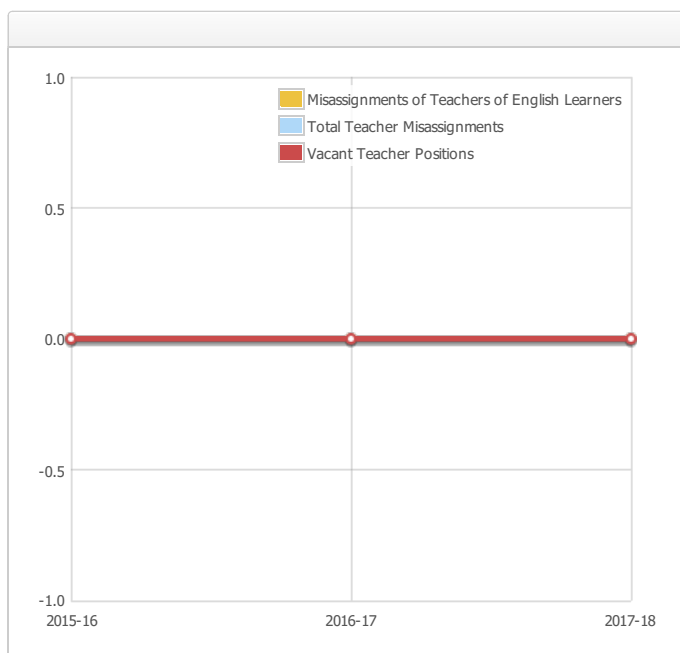

Pescadero High School is a closed campus. Only seniors in good academic and behavioral standing may leave campus during breaks under the Senior Privilege Program. Students participating in after-school tutoring, sports, or class events are supervised at all times.
